— Lifetime warranty on static control properties on all ESD floor covering products from StaticWorx, Inc —

StaticWorx ESD rubber products are warranted for a period of one year from date of installation to be free of defects in material and workmanship, if installed, maintained, and used strictly in accordance with StaticWorx' written instructions. **NOTIFICATION OF CLAIMS AGAINST WARRANTY**

This warranty does not cover dissatisfaction, problems or damage due to installation or maintenance other than as recommended by StaticWorx, Inc.. All claims under this warranty must be submitted, in writing, within five (5) days of discovery of any defect to:

Status of claims will be based on complete inspection of installation. All claims not submitted in writing and received by StaticWorx, Inc. within the time period specified above shall be waived.

**EXCESSIVE WEAR**

StaticWorx warrants for a period of five (5) years that their ESD Rubber products will not wear in excess of <.0035" wear per year prorated from the date of purchase.

**STATIC PROTECTION**

StaticWorx offers a lifetime warranty on the static control properties for this ESD floor covering product, if the rubber floorcovering is installed with the recommended StaticWorx, Inc. Conductive Adhesive.

When tested according to the test procedures of ESD S7.1-94 and ASTM-F-150 under >30% RH at room temperature, StaticWorx

ESD Rubber will measure either between  $<1 \times 10^6$  OHMS or between  $10^6$  - $<10^9$  OHMS as specified for that product in the technical data sheet provided by StaticWorx.

**OBLIGATIONS OF WARRANTOR**

Buyer's exclusive remedy against StaticWorx for claims arising hereunder for any and all losses and damages resulting from any cause shall be receipt of, at StaticWorx' option, either replacement of the defective merchandise, or a refund of the sale price of the defective merchandise.

Except for the limited warranties set forth within, StaticWorx extends no other warranties or guarantees, either expressed or implied, including, but not limited to warranties of merchantability or fitness for a particular purpose, or exact matching of shade, color or mottling. In no event shall StaticWorx be liable for incidental or consequential damages, even if some other provision of this Limited Warranty is unenforceable. Buyer waives all other claims and remedies of any nature. StaticWorx shall not be held liable directly or indirectly for any losses, claims or damages regarding any products that have not been installed and maintained according to StaticWorx' installation and maintenance instructions, that were damaged by a third party, that were installed over an improper subsurface or improperly prepared subfloor, that were improperly repaired, or that were affected by any other mechanical influences. StaticWorx shall not be liable for any incidental, consequential, enhanced or punitive damages.

These warranties are expressly in lieu of any other warranties expressed or implied, including, but not limited to any implied warranty of merchantability or fitness for a particular purpose. By retaining StaticWorx merchandise for more than five (5) days after receipt of such merchandise, buyer agrees that it accepts the terms of this Limited Warranty and that there are no warranties or rights beyond those contained herein.
